Hopelink waxaa ka go'an hubinta in qofna aan laga reebin ka qeybqaadashada ama loo diidin dheefaha adeegyadooda gaadiidka sida ku saleysan isirka, midibka, ama wadanka dhalashada, sida ku illaalsan Title VI ee Wareegtada Maamulka Gaadiidka Dadweynaha ee Dawlada Dhexe (Federal Transit Administration, FTA) ee 4702.1.A Haddii aad aaminsantahay in laguugula kacay takoorid sida waafaqsan Title VI, waxaad xareyn kartaa cabasho.

Sida loo xareeyo Cabashada Title VI

Waxaad xareyn kartaa cabasho saxiixan, qoraal ah oo illaa boqol iyo sideedan (180) maalmood laga bilaabo taariiqda takoorida lagu eedeeyay. Cabashada waa inay ku jiraan macluumaadka soo socda:

- Magacaaga, ciwaanka boostada, iyo sida laguula soo xiriiro (tusaale ahaan, lambarka talefoonka, ciwaanka iimaylka, iwm.)
- Sidee, goorma, halkee, iyo sababta aad u aaminsantahay in lagu takooray. Ku dar goobta, magacyada, iyo macluumaadka xiriirka ee marqaati walba.
- Macluumaad kale ee aad u aragtid muhiim

Macaamiisha ku hadlaa luuqad aan ka aheyn Ingiriis, Hopelink waxay isticmaaleysaa adeegyada Language Line si ay u fududeeyaan wacitaanada.

Maxaa ku dhaco cabashadaada kadib markii loo gudbiyo Hopelink?

Hopelink waxay si toos ah wax uga qabanaysaa cabashooyinkoo dhan ee ku eedeynayo takoorida ku saleysan isirk, midibka, ama wadanka u dhalashada ee adeega ama dheefaha ay bixiyaan Hopelink. Hopelink ayaa sidoo kale siineysa caawin ku haboon cowdayaasha, oo ay ku jiraan dadka naafada ah, ama kuwaasoo ay xadidantahay awoodooda ay ugu xiriiraan Ingiriis. Waxaa dheeraad ah, Hopelink waxay sameyneysaa dadaal walba ee wax looga qabanayo cabashooyinkoo dhan si degdeg ah oo dhameystiran. .

Haddii warbixin dheeraad ah loo baahdo si loo baaro cabashada, Hopelink waxay la soo xiriiraysaa qofka cabanaya. Fadlan ogow in ka jawaabida codsiyada macluumaadka dheeraadka ah, guuldarada cowdaha ee lagu bixinayo warbixinta la codsaday waxay sababi kartaa xiritaanka maamulka ee cabashada.

Dadaal walba waxaa loo sameynayaa in looga jawaabo cabashooyinka Title VI 60 maalmood shaqo gudahood ee helida cabashooyin noocaas ah, haddii aysan ku dhicin.

Hopelink waxay hayneysaa feelasha cabashada oo muddu ugu badnaan 6 sanno ah ka badan dhammaadka mashruuca iyadoo la raacayo Jadwalka Diiwaanada Guud ee Xafiiska Keydka Gobolka Washington iyo shuruudaha Barnaamijka Deeqaha Isku dhafka ah ee Waaxda Gaadiidka ee Gobalka Washington (Washington State Department of Transportation, WSDOT). Feelasha cabashada Hopelink waxaa ka mid noqonayo:

- Taariiqda Hopelink ay heshay cabashada.
- Soo koobitaanka eedeymaha cabashada.
- Xaalada cabashada.
- Tallooyinka ay qaadeen Hopelink, oo ay ku jiraan, haddii ay quseyso, u gudbinta cabashada baaritaanka Waaxda Gaadiidka ee Gobalka Washington (Washington State Department of Transportation, WSDOT), Maamulka Gaadiidka Dawlada Dhexe (Federal Transit Administration), ama Waaxda Cadaalada Mareykanka (U.S. Department of Justice).

I. Diiwaanka Title VI ama Xaquuqaha Kale ee Rayidka, Baaritaanada, Cabashooyinka ama Dacwadaha

Ilaa iyo hada, ma jirin baaritaanada Title VI, cabashooyinka ama dacwadaha.

II. Qorshaha Aqoonta Kooban ee Ingiriiska (LEP)

Hopelink waxaa ka go'an inay jabiso caqabadaha luuqada iyagoo higelinayo heerar iswaafaqsan oo caawinta luuqada oo aagooda adeega.

Tirikoobka.

Maraykanka wuxuu hoy u yahay malaayiin qof asalka dhalashada dadka laga tiro badanyahay kuwaasoo leh Aqoonta Ingiriiska Kooban (Limited English Proficient, LEP). Taasoo ah, in luuqadooda koowaad aysan aheyn Ingiriis, oo kuma hadli karaan, ma aqriyaan, ma qoraan ama ma fahmaan luuqada Ingiriiska ee heerka u ogolaanayo inay si wax ku ool ah u dhaxgalaan helayaasha caawinta dhaqaalaha Dawlada dhexe.

Sababtoo ah kala duwanaanshaha luuqada iyo awood la'aanta ay si waxtar ah ugu hadlaan ama u fahmaan Ingiriiska, dadka leh Aqoonta Kooban ee Ingriisiga (Limited English proficiency, LEP) waxaa quseyn karo ka reebida barnaamijka ama howlaha, daahitaanada waaya aragnimada ama diidmada adeegyada. Shaqsiyaadkaan waxay xaq u yeelan karaan caawinta luuqada ee quseyso nooc gaar ah ee adeega. Dowlada dhexe iyo kuwa ka helayo caawin dowlada dhexe waa inay qaadaan talaabo macquul ah oo lagu hubinayo in dadka leh Aqoonta Kooban ee Ingriisiga (Limited English proficiency, LEP) ay helaan helitaan waxtar leh ee barnaamijyada, adeegyada, iyo macluumaad hay'adahaas ay bixiyeen.

Tan waxay uga baahaneysaa hay'adaha inay aasaasaan xalal hal abuur ah oo wax looga qabanayo baahiyaha dadyowgaan abid korayo oo Ingiriiskooda uusan aheyn luuqada koowaad.

Sida waafaqsan Xogta Sahanka Bulshada Mareykanka ee King County ee 2018, Ingiriiska waxaa ku hadlo boqolkiiba 89.5% ee King County. Mida xigta waxay matashaa boqoleyda ee qoysaska aanan ku fiicneyn Ingiriiska oo luuqad ahaan.

Gudaha King County, 214,094 dad (10.5%) ayaa leh aqoonta Ingiriiska xadidan; taasoo ah, inay ugu hadlaan Ingiriiska ka yar “aad u wanaagsan”. Dadkaas leh aqoonta Ingiriiska xadidan, qiyaastii boqolkiiba 49% ayaa ku hadlo luuqadaha Aasiyaanka iyo Jasiiradaha baasifiga, boqolkiiba 25% ayaa ku hadlo Isbaanish, boqolkiiba 17% waxay ku hadlaan luuqadaha kale ee Indo-European, iyo 9% waxay ku hadlaan luuqado kale.

Xaqqiida Lambarka 1: Tirada ama saamiga dadka leh Aqoonta Kooban ee Ingriisiga (Limited English proficiency, LEP) ee aaga adeega.

Xukunka Hopelink wuxuu daboolaa dhammaan Gobolka King, kaasoo si weyn ugu hadlo Ingiriis. Dadweynaha badankood oo aan ganacsi sameyno (shaqsiyaadka rabo inay raacaan gaadiidka) ku hadlaan Ingiriis, inkastoo aan sidoo kale ku dadaalno inaan u adeegno xubnaha bulshada ee aan ku hadlin Ingiriis sidoo kale. Dib u eegida Tirikoobka 2021, hoos waa qiyaasaha luuqadaha ugu badan ee looga hadlo King County:

Xaqiiqda Lambarka 2. Inta jeer ee dadka leh Aqoonta Kooban ee Ingriisiga (Limited English proficiency, LEP) ay la soo xiriireen adeega.

Dhamaan xiriirada Hopelink waxaa lagu sameeyaa qof ahaan ama ka qeybgalada taleefonka. Waxaan u adeegnaa dadka leh Aqoonta Kooban ee Ingriisiga (Limited English proficiency, LEP) maalin walba iyo dhinaca shanteena xarumo ee adeega, xarunta wacitaanka gaadiidka caafimaadka aan xaaladaha degdega aheyn, ama kala duwanaanshaha barnaamijka Mobility Management. Sanadka maaliyadeedka 2024, Hopelink Maamulka Gaadiidka (Mobility Management) waxay adeegyo siisaa 247 macaamiil iyada oo loo marayo jiheynada gaadiidka dadweynaha, kuwaasoo bartilmaameedsada muhaajiriinta iyo qaxooyiyada leh aqoonta Ingiriiska kooban.

Xaqiiqda Lambarka 3: Nooca iyo muhiimada adeega ay bixiyaan Hopelink.

Hopelink waxay bixisaa adeegyo muhiim u ah dadweynaha oo loo marayo habeynta isku dhafan ee barnaamijyada u suurto geliyo qoysaska dhibaatooyinka ku jiro inay u hormaraan isku filnaansho. Barnaamijyada Hopelink waxay diirada saaraan cuntada, guriyeynta, hormarinta qoyska, waxbarashada dadka weyn (oo ay ku jiraan barnaamijyada farbarashada), gaadiidka, iyo caawinta maaliyada degdega ah.

Daahitaanada adeegyada Hopelink sabab la xiriirto caqabadaha luuqada waxay si daran u saameyneysaa macaamiishooda. Tusaale ahaan, gaadiidka caafimaadka aan xaalada degdega aheyn ee Hopelink oo macaamiisha Medicaid waxay siiyaan helitaanka daryeel caafimaad oo aad loogu baahanyahay shaqsiyaad badan oo daqligooda caafimaadka hooseeyo iyo leh Aqoonta Ingiriiska Xadidan.

Dagayaal badan oo King County, awood la'aanta lagu fahmayo ama lagu qorsheynayo nidaamka gaadiidka dadweynaha ayaa caqabad ku noqdo in la helo. Tan ayaa si gaar ah run ugu ah dadyowga nugul iyo kuwa

ku cusub wadankaan, oo ay ku jiraan dadka naafada ah, dadka waayeelka, shaqsiyaadka daqliga hoose, iyo kuwa leh aqoonta Ingiriiska xadidan. Kooxda Mobility Management Hopelink waxay ku bixiyaan waxbarasho iyo barnaamijyo kheyraadka badan oo tababarka safarka King County oo dhan. Barnaamijyada waxay bixiyaan warbixin ku saabsan dooqyada safarka, qorshooyinka safarka, caawinta gaadiidka qof ku qof, iyo tababarka jaalalka la shaqeeyo macaamiisha. Gudaha 2023, 12,345 dad ayaa ku helay kheyraad barnaamijyadaan.

Xaqiiqda Lambarka 4. Kheyraadkaloo heli karo helayaasha lacagaha dawlada dhexe si loo hubsado helitaan waxtar leh ee adeega oo dadka leh Aqoonta Kooban ee Ingriisiga (Limited English proficiency, LEP).

Hopelink waxay howlgeliyaan shaqaale taageero kala duwanaanshaha macaamiisheena. Waxaan sidoo kale isticmaalnaa Language Line iyo adeegyada turjumaada muuqaalka si aan u daboolno baahiyaha macaamiisheena.

Buug-yarayaasha barnaamijka Gaadiidka Caafimaadka waxaa loo turjumay Raashiyaan iyo Isbaanish. Adeegyada Bulshada waxay ku bixiyaan qoraalada wacyigelinta luuqado badan, sidoo kale sida saxiixa qeybta nooceena cuntada dukaanka. Hopelink ayaa sidoo kale u fasirto foomamka macluumaadka, sahanada iyo foomamka kale sida loogu baahdo. Gudaha Mobility Management, in ka badan \$7,000 ayaa lagu isticmaalay adeegyada turjubaanka iyo turjumaada ee FY2024.

III. Qorshaha Hirgelinta

Hopelink waxay hirgelisay qorshahooda oo waxay dib u eegeysaa sannad walba, oo ay ku jiraan xiriiro walba ee dadka leh Aqoonta Kooban ee Ingriisiga (Limited English proficiency, LEP), si ay u go'aamiyaan inta jeer oo xiriirada ah, luuqada la adeegsaday, iyo sida xiriirada loo qaabilay.

Waxaan ku aqoonsanaa dadka leh Aqoonta Kooban ee Ingriisiga (Limited English proficiency, LEP) aaga adeega inagoo la kaashaneyno ururada bulshada ku saleysan ee u adeego dadyowga leh Aqoonta Kooban ee Ingriisiga (Limited English proficiency, LEP) oo ay ku jiraan hay'adaha dib u dajinta, ururada adeega bulshada, iyo hay'adaha udoodista soo galootiga. Wacitaan ka jawaabayaasha ayaa loo tababaray inay isticmaalaan adeegyada Language Line. Inta badan buug-yarayaasha iyo qoraalada wacyigelinta Mobility Management waxaa loo turjumaada luuqadaha ugu muhiimsan, iyo wargeyskeena elektarooniga wacyigelinta waxaa lagu helayaa Ingiriis iyo Isbaanish. Xeerka Title VI ee Hopelink iyo Foomka Cabashada waxaa laga helayaa websaydkeena. Dhammaan qoraalada daabacaada Mobility Management, ajendayaasha, iyo jaraa'idyada waxay wataan xeerkeena Title VI. Intaas waxaa dheer, shaqaalaha waxaa loo tababaray sida qorshooyinka Title VI ugu shaqeeyo inuu waafaqsanaado codsigooda.

Si aad ugu hogaansantid 49 Xeerka Shuruucda Dawlada Dhexe (Code of Federal Regulations, CFR)21.9(d), Hopelink iyo heleyaasheeda hoose waa inay siiyaan warbixin ka faa'ideystayaasha oo la xiriiro waajibaadyadooda Title VI iyo ogeysiiyo ka faa'ideystayaasha illaalada ka soo horjeedo takoorida oo iyaga ay u awoodaan Title VI. Hopelink waxay sameysay bayaanka xaquuqaha iyo bayaanka xeerka.

IV. Ogeysiinta Ka faa'ideystayaasha Xaquuqahooda sida waafaqsan Title VI

1. Websaydkeena waxaa ku jiro foomkeena xeerka iyo cabashada Title VI.
2. Xeerkeena Title VI, oo ay ku jiraan sida loo helo ogeysiinta xeerkaan oo afar luuqad oo kale, waxaa laga muujiyaa ajendaha kulankeena isbaheysiga dibada iyo wargeyska elektarooniga ee jaalalka dibada.

V. Falanqeynta Mashaariicda Dhismaha

In ka badan sadexdii sanno ee la soo dhaafay, Hopelink maysan dhameystirin mashruuc dhismo oo u baahan qiimeynta deegaanka (Environmental Assessment, EA) ama bayaanka saameynta deegaanka (Environmental Impact Statement, EIS).

VI. Ka qeybqaadashada Dadweynaha ee Loo dhanyahay

Wacyigelinta Bulshada waa sharuuda Title VI. Helayaasha iyo helayaasha hoose waa inay raadiyaan oo tixgeliyaan aragtiyada dadka laga tiro badanyahay iyo dadyowga daqliga hoose iyadoo la sameynayo wacyigelinta dadweynaha. Helayaasha waxay haystaan xoriyada siday rabaan inay u go'aamiyaan tallaabooyinka gaarka ah ee aadka ugu haboon. Waa inay gaaraan go'aamintaan sida ku saleysan ee ay ka koobantahay dadyowga ay saameysay, nidaamka ku luglahaanshaha dadweynaha, iyo illaha Hopelink.

Hopelink waxay ka qeybgelisay dadweynaha nidaamyadooda qorsheynta iyo go'aan gaarista, sidoo kale sida howlahooda suuq-geynta iyo wacyigelinta. Hopelink waxay sameeyeen Qorshaha Ka qeybqaadashada Dadweynaha (Public Participation Plan, PPP), kaasoo tilmaamo yoolalka iyo ujeedooyinka ka qeybqaadashada dadweynaha (Fiiri Lifaafa C).

Bisha Maarso 2024, waxaan ku dhafnay qorsheeyaha safarka cusub websaytkeena FindARide.org. Waxay diirada saartaa baahiyaha dhaqaaqa ee dadka waayeelka iyo dadka naafada ah ee dhammaan gobolada Pierce, King, iyo Snohomish. Qorsheeyaha safarka waa Wajiga 1 ee qorshaha wajiyada badan iyo hormarinteen Halka Wacitaan/Halka Taabashada. Hormarinta qorsheeyaha safarkeena waxaa lagu suurtoogeliyay taageerada Waaxda Gaadiidka Gobolka Washington (Washington State Department of Transportation), King County Metro, Sound Transit, Hopelink, iyo iskaashatada kale. Fikrad ka qaadashada aaladan waxay si toos ah uga timid qorsheynta loo dhanyahay.

Mobility Management Hopelink waxay martigelisaa kulamada isbaheysiga dhaqaaqa joogtada ah ee dhammaan King County, iyo in ka badan 100 ururo gaar ah oo ka qeybqaadanayo 2024. Waxaan sidoo kale sameynaa wacyigelinta bulshada ee goobaha jaalka, oo ay ku jiraan bandhigyada illaha, dhismooyinka guriyaha, maktabadaha, qeybaha cuntada, xarumaha caafimaadka, xarumaha waayeelka, iyo ururada adeega bulshada.
